RESTATED ARTICLES OF INCORPORATION Restated September 19, 2011

ARTICLE I: NAME AND PRINCIPAL OFFICE

Section 1.1 Name. The name of this nonprofit, public benefit corporation is NORTHWEST LAND CONSERVATION TRUST, hereinafter referred to as "NWLCT".

Section 1.2 <u>Principal Office</u>. The principal office of NWLCT in the State of Oregon shall be located in Marion County. NWLCT may have such other offices within the State of Oregon, as the activities of the Trust may require from time to time. The address of the principal office at the time of incorporation is: Northwest Land Conservation Trust, 5664 Davis Creek Road, N. E., Silverton, OR, 97381. As of September 19, 2011, the principal office is: Northwest Land Conservation Trust, P. O. Box 613, Turner, OR, 97392, located at 6516 Hunsaker Road, S.E., Turner, OR, 97392.

ARTICLE II: PURPOSE

Section 2.1. <u>Purpose.</u> NWLCT is organized under the nonprofit public benefit corporation law of Oregon (ORS Chapter 65) exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986. The purpose of NWLCT shall be to protect and preserve natural, scenic, agricultural, forest, recreational and open space lands in the State of Oregon, by acquiring properties (including by conservation easements as defined in ORS 271.715 to 271.795) and to use said properties or the proceeds thereof, to accomplish such purposes.

ARTICLE III: POWERS AND OPERATION

Section 3.1 <u>Powers.</u> NWLCT shall have all the powers granted by law which are necessary and proper to carry out its stated purpose, consistent with its qualifications under ORS Chapter 65 and Section 501(c)(3) of the Internal Revenue Code.

Section 3.2 Operation. NWLCT will:

(a) Promote, by means of education, the public's awareness of the need for conservation of waters, wetlands, aquatic and wildlife habitat, timber lands, scenic lands, open spaces, recreational and agricultural lands in the State of Oregon;

- (b) Encourage, through education and solicitation, public support of NWLCT's goals of acquiring properties, conservation easements, other property rights, financial contributions, and volunteer services, for preserving and maintaining in perpetuity the property that comes under the NWLCT's stewardship.
- Section 3.3 <u>Limitations.</u> No part of the net earnings of NWLCT shall inure to the benefit of, or be distributable to, its trustees, directors, officers or other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements.

Notwithstanding any other provision of these Articles, NWLCT shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or corresponding provisions of any future Federal Tax Code.

ARTICLE IV. MEMBERSHIP

Section 4.1 Members. NWLCT shall have no members.

ARTICLE V. BOARD OF DIRECTORS

ARTICLE VI: LIABILITY OF DIRECTORS

Section 6.1 <u>Liability.</u> Directors shall have no personal liability to NWLCT for monetary damages for conduct as a Director except for:

- (a) breach of the Director's duty of loyalty to the Trust;
- (b) acts or omissions not in good faith which involve intentional misconduct or a knowing violation of law;
- (c) any unlawful distribution;
- (d) any transaction from which the Director derived an improper personal benefit; and
- (e) any act or omission in violation of ORS 65.361 to 65.367.

ARTICLE VII: INITIAL REGISTERED AGENT

Section 7.1 Agent. The name and address of the initial registered Agent is: Malcolm B. Higgins, 5664 Davis Creek Road, N. E., Silverton, Oregon, 97381.

ARTICLE VIII. AMENDMENT

Section 8.1 <u>Amendment.</u> The Board of Directors shall have full unrestricted power to adopt, alter, amend, or replace the Articles of Incorporation and/or By-Laws, at any time. Procedures for amendment of By-Laws or the Articles of Incorporation are provided for in the By-Laws.

ARTICLE IX: DISSOLUTION

Section 9.1 <u>Dissolution</u>. Upon the dissolution and winding up of the corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed by the Board of Directors to a nonprofit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in § 501(c)(3) of the Internal Revenue Code and which has established its tax-exempt status under that section. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
